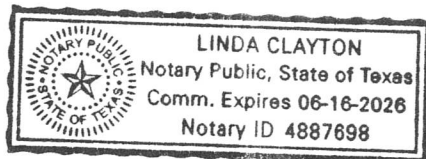

ELECTION ON DISCLOSURE FOR CITY APPOINTEES
